In consideration of the following and of the acceptance of my application and the permission to participate as an entrant or competitor in the 2018 Santa Run at Camana Bay (the "Event"), I, for myself, my heirs, executors, administrators, successors and assigns and for any minor on whose behalf I understand and acknowledge I am signing this waiver for (collectively the "Releasors"), hereby fully release, waive and forever discharge Cayman Shores Development Ltd. its parent, subsidiary and affiliate companies, all contributors, contractors, participants, employees, volunteers, and sanctioning bodies (the "Released Parties") of and from any and all claims, demands, costs, expenses, actions and causes of action, whether in law or equity, in respect of death, injury, loss or damage to myself or the Releasors or property, however caused, arising or to arise in connection with the Releasors' participation in the said Event, whether as a spectator, participant, competitor or otherwise, whether prior to, during or subsequent to the Event, and of any of the aforesaid.

The Releasors further hereby undertake to save and hold harmless and agree to fully indemnify all of the aforesaid from and against any and all liability incurred by all of them as a result of, or in any way connected or associated with, the Releasors' participation in the Event. By submitting and signing this form the Releasors acknowledge, having read and agreed to the above waiver, release and indemnity, that it is understood this document constitutes a complete waiver of their right to commence any legal proceedings.

The Releasors further acknowledge that they understand there are risks associated with participating in the Event, that they are responsible for the risk of participation in the Event including the risks related to COVID-19 as outlined below and that they are physically fit to participate in this Event. The Releasors further acknowledge that these risks include risks that may be the result of negligent acts, omissions, and/or carelessness of the Released Parties, as defined herein.

The Releasors assume any and all risks from their voluntary participation in this Event and its related activities; including, but not limited to wearing the T-shirt provided to me by CSDL for the duration of the Event, physical activity in public during a period of worldwide pandemic, falls, slips, trips, accidents, contact with other participants, effects of the weather (including all those risks associated with heat, humidity and precipitation), traffic, users of the road and the conditions of the road, all such risks being known and appreciated by them.

The novel coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, contact with contaminated surfaces and/or objects and, even possibly, by air. As a result, the Cayman Islands Government has recommended social distancing and has, in certain locations, restricted or prohibited the congregation of groups of people. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death. The Released Parties cannot prevent the Releasors from becoming exposed to, contracting or spreading COVID-19 whilst participating in the Event or entering premises in connection with the Event.

The Event will be governed by such limits for public gatherings as imposed by the Cayman Islands' Government's restrictions and limitations pursuant to the relevant COVID-19 regulations and, as such CSDL may have to limit or restrict participation in the Event or terminate the Event on short or no notice in order to comply with any laws or regulations imposed by the Cayman Islands Government.

Releasors confirm that they have read and understood the above warning concerning COVID-19. Participating in the Event is of such value to them that they accept the risk of being exposed to, contracting and/or spreading COVID-19 in order to participate in the Event and/ or enter the premises in person.

Without prejudice to the other terms of this document, I hereby forever release and waive my right to bring suit against the Released Parties in connection with the exposure, infection and/or spread of COVID-19 related to participating in the Event or entering premises in connection with the Event.

With Participant's consent, it is agreed to grant to the Company and the Company's successors and assigns an irrevocable, sub-licensable right and authority to use Participant's recorded likeness, photograph and/or picture for any and all commercial or non-commercial purposes now known or later developed in perpetuity throughout the universe without further obligation or compensation to Participant. The Participant understands that CSDL will be collecting his/her personal data (including name and/or image) in connection with this Confirmation, Waiver and Indemnity and the Event and the Participant hereby consents to the collection, use and processing of such personal data for the purposes of same.
